### **EXHIBIT A**

## TERMS AND CONDITIONS

SPONSOR/EXHIBITOR AND STATION AGREE THAT THE FOLLOWING TERMS AND CONDITIONS FORM A PART OF THE AGREEMENT BETWEEN THEM WITH RESPECT TO SPONSOR/EXHIBITOR'S PARTICIPATION IN THE EVENT. SPONSOR/EXHIBITOR'S ADHERENCE TO THESE TERMS AND CONDITIONS ARE ESSENTIAL TO SPONSOR/EXHIBITOR'S PARTICIPATION.

#### **SECTION 1: ON-AIR PROMOTION**

Broadcast schedules and promotions for the Event will run from **December 17, 2015** – **February 26, 2016**. Please note that only rates supplied by Station in conjunction with this special offer will be considered in determining flight schedules. Annual or quarterly rates at any other time are not applicable.

Upon mutual agreement of Sponsor/Exhibitor's ad schedule, the schedule will be incorporated with this Sponsor/Exhibitor Agreement and is subject to Station's Standard Conditions attached as Exhibit C.

### **SECTION 2: CANCELLATION POLICY**

THIS AGREEMENT CANNOT BE CANCELED. IF SPONSOR/EXHIBITOR CANCELS ITS PARTICIPATION FOR ANY REASON, SPONSOR/EXHIBITOR REMAINS RESPONSIBLE FOR ITS ENTIRE CONTRIBUTION AMOUNT.

## SECTION 3: SALE OF MERCHANDISE AND/OR SAMPLE HANDOUTS

Sponsors/Exhibitors wishing to sell merchandise or distribute free samples at the Event must first obtain written permission from Station and the Location/Venue. Approval to sell merchandise or hand out samples will be granted on an individual basis at the Station's discretion. If permission to sell merchandise is granted, Sponsors/Exhibitors must have in advance, and display at their booth, their state Sales Tax Identification Number. No Sponsor/Exhibitor will be permitted to sell items otherwise. Distribution of reasonably-sized free food samples are permitted, however Sponsor/Exhibitor must notify Station in advance. Sales of any food or beverage are not permitted.

## **SECTION 4: MEDICAL TESTING**

For medical testing of an invasive nature, or that involving bodily fluids, Sponsors/Exhibitors must have a current CLIA from the state health department applicable to the Location/Venue. All Sponsors/Exhibitors must notify their Station's sales representative beforehand to receive approval for any testing and screening.

### **SECTION 5: UTILITIES/SERVICES**

Sponsor/Exhibitor acknowledges that utility services including electric, water, sewer, and internet are provided exclusively by the Location/Venue. Station shall not be responsible for technical difficulties or service interruptions of any kind.

#### **SECTION 6: INSURANCE**

- General Liability (all Sponsor/Exhibitors participating in the KUTV2 Health Expo at the 9575 State Street, Sandy, UT 84070.
- Automobile (for Sponsor/Exhibitors planning to bring a mobile unit or vehicle into the venue)
- Product Liability (for Sponsor/Exhibitors planning to sample)
- Professional Liability (for Sponsor/Exhibitors providing health testing)

Sponsor/Exhibitor agrees to INDEMNIFY, RELEASE, FOREVER DISCHARGE, HOLD HARMLESS AND CONVENANT NOT TO MAKE A CLAIM OR SUE Station, Sinclair Broadcast Group, Inc., their subsidiaries and divisions, all sponsors of the event, their owners, stockholders, directors, board of trustees, officers, employees, agents, insurers, representatives, successors, heirs and assigns, and each and every person acting by, through, under, or in concert with them ("Released Parties") from all manner of action or actions, cause or causes of actions, at law or in equity, suits, claims, demands, liability, cost or expense of any nature, known or unknown, fixed on contingent ("Claims") which Sponsor/Exhibitor may have against the Released Parties (or which any third party has against Released Parties relating to, or result of, Sponsor/Exhibitor's actions or omissions, or product(s)/service(s) provided by

Sponsor/Exhibitor) by reason of any injuries or damages that may be sustained as a result of, or incident to Sponsor/Exhibitor's participation in the Event.

Sponsor/Exhibitor agrees that if it commences, joins in, or in any way seeks relief through any suit arising out of, based upon, or relating to any of the claims released above, or in any way asserts against the Released Parties any of the Claims released above, then it will pay to the Released Parties, in addition to any other damage caused to the Released Parties thereby, all costs, including but not limited to attorney's fees, incurred by the Released Parties in defending or otherwise responding to said suit, action or claims.
